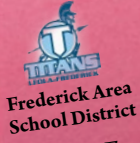

## Bakeberg is a 2019 Rural Pride Honoree

When the Cenex station in Frederick closed, the closest fueling option was 12 miles away in Ellendale, N.D. So, members of the Frederick Development Corporation began searching for other options.

The plan they finally went with was a creative one. The Development Corporation built a self-service fuel station and lease the facility to Agtegra. The local cooperative takes care of everything else.

"After going without a local gas station for quite a while, this was a big success for us and our community," explains Rich Bakeberg, volunteer chair of the Development Corporation and a 2019 recipient of South Dakota Farmers Union Rural Dakota Pride honor.

A longtime resident of Frederick, Rich donates his time to projects that help make Frederick a community welcoming to young families. Like he and his wife, Gayle, were when they moved to town to raise their family 44 years ago.

"Our focus is to keep Frederick thriving and growing – any opportunities we can create to get new families to the community we will work to do," explains Rich, who retired four years ago, and then went back to work part-time when Frederick needed a part-time Maintenance manager.

For more than four decades he has served as a volunteer firefighter and spent 25 years with the volunteer ambulance service. For years he kept score for high school basketball games, and when the school needed a bus driver for away games, Rich passed the test so he could do the job.

"I figured, I have three sons and this way I get to watch every game courtside. I was blessed, we got to watch eight Class B State Tournaments while I was volunteer score keeper," Rich, a veteran, shares. "Frederick is a good place to live and it was a good place to raise my family, and our school system is terrific. We have smaller class size, so students don't get lost in the crowd."

In fact, the Frederick Area School has such a good reputation, students from 30 miles away in Aberdeen choose to open enroll. To make it an easy decision for families, the school funds a bus to pick up and drop off students.

"We hope that some of the students' families will be impressed enough with Frederick that they want to move here," he says.

In fact, some student's families have inquired about moving to Frederick, but housing availability was an obstacle. Fortunately, increasing housing options is another project the Development Corporation has undertaken since Rich joined the board more than two decades ago. Currently the organization manages eight apartments, and this summer they will fund the building of a four-bedroom home.

"I get to work with a lot of great people," Bakeberg explains. "In small towns, we all need to volunteer and help out wherever we can. For me, Frederick is my number one priority."

### More about Rural Dakota Pride

Rich is one of five volunteers recognized for their selfless contributions to South Dakota rural communities by South Dakota Farmers Union (SDFU) with the 2019 Rural Dakota Pride Honor August 31, during the 2019 South Dakota State Fair.

"Community is created and maintained through the efforts of volunteers," explains Karla Hofhenke, SDFU Executive Director.

The other 2019 Rural Dakota Pride honorees include: Angie Mueller, Ethan; Jeannie Hofer, Huron; Jim Lane, Groton and Franklin Olson, Pierpont.

As an organization which serves South Dakota's family farmers and ranchers, Doug Sombke, SDFU President, says Farmers Union recognizes the important role strong rural communities play in supporting agriculture producers and their families.

"South Dakota's agriculture producers and their communities are closely connected. In good economic times they both prosper. When the economy is down, like today with the trade war, low commodity prices and extreme weather conditions, they both feel the pain," Sombke said. "The Rural Dakota Pride honor is one of many ways SDFU works to show our support for both."

possibilities after that as well, but again, both of them accepted jobs at other districts. We were finally able to get a candidate hired in July. Bradley Miedema will join the Frederick Area staff and brings 25 years of experience in the music education area, spanning elementary to high school to the collegiate level. I am excited for the experience and expertise he will bring to the program.

## Additional class period

The length of the school day did not change, but the periods within the day have gone from seven periods to eight. Previously, the length of each period was 57 minutes; the change will reduce the time for each period to 50 minutes. The change will allow for more flexibility in scheduling for the junior high and high school students, while allowing the elementary more flexibility in the scheduling of their specials (music, physical education, etc.).

## Attendance policy adjusted

The Student Handbook has changed in several ways. For the most part, the changes were minor in scope and were implemented to clean up some of the verbiage and make things

clearer and easy to interpret. I would encourage parents and students alike to take a closer look at the handbook when it comes home in the student folders—particularly the attendance section, as that is one of the bigger changes with regard to policy. I will go over some of the finer points with the student body on the first day of school.

## More writing in English classes

We have also upgraded our ELA (English Language Arts) curriculum this year. We will be using “MyView” for the elementary and “MyPerspectives” for the Jr High and High School students. The new curriculum fits the standards well and has a much stronger push in writing.

## “In God We Trust” on the wall

Per Senate Bill 55 this past legislative session, school districts are now required to display the national motto of the United States. I had a short conversation with Mrs. Arthurs (Art teacher) about it, and she was nice enough to lend her talents to helping us take care of that. Upon entering the school, individuals will see the aforementioned piece on the east wall in the lobby area. She did a super nice job!

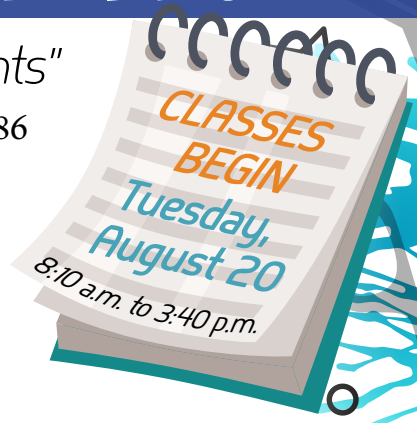

### New Business:

LeRoy and Sharon Ham had concern about unmarked vehicles in their neighbor's yards as well as overgrown yards. The board discussed the city ordinances that don't allow either of these things and will be sending a notice

to the neighbors.

The board accepted a proposal to clean the water tower from Maguire Iron, Inc. with a motion to accept by R.S. Campbell/T. Millard. Motion Carried.

Gary Peterson asked about a tax break for the new spec house in Frederick. He proposed a plan of lower property taxes for the new homeowner increasing each year charging 20% of the taxes the first year, 40% the second year up to the full amount in the fifth year and going forward. He expressed that this would be very beneficial for the new homeowner and would help encourage someone to move to Frederick. The city was interested in the idea and will look into the next steps. Gary Peterson also would like to seek a variance on the spec house by moving it forward 15 feet closer to the road to allow leaving a tree in place in the backyard. The city will publish a notice and schedule a special meeting.

An offer was made by Melanie Flinn to pay \$2000 to pay off the debt to the city for removing the rubble from their yard. The board chose to decline the offer and made a motion to add it to their taxes with a motion by G. Schlosser/T. Millard. Motion Carried.

There was a discussion about storage pods in town to which the board will create a new ordinance to address the use of storage pods in the city.

The city sent an application for a mosquito control grant and awaits to hear a response.

The board reviewed the Restricted Use Facility Report by Don Rosowitz of DENR.

There was a question to the board about vacation rates for homes in Frederick used strictly for hunters. The board discussed that they can choose to have their water shut off while they are gone to not be charged water fees.

The board received estimates for repairs on the door for the community center and back bathroom. The board would like to table the offer to next month, but approved a motion to get a new quote to change the old back bathroom into a janitor's closet with a floor sink. Motion made by T. Millard/G. Schlosser. Motion Carried.

Tamie Nickelson discussed a meeting of townspeople where they discussed

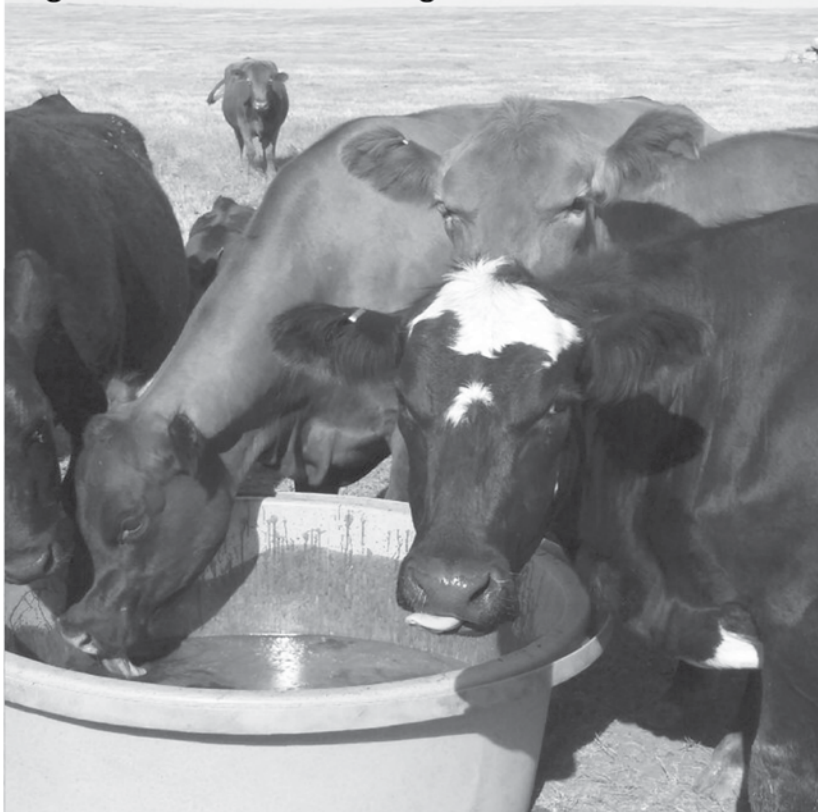

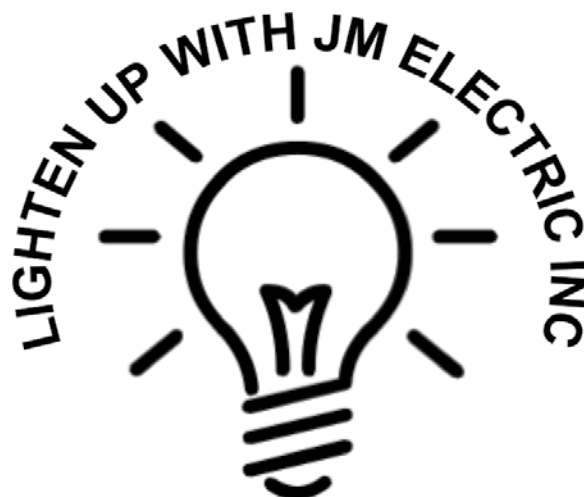

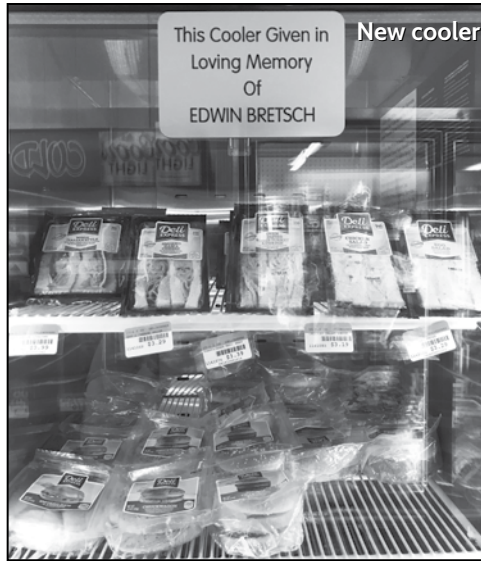

find in large grocery stores,” she said. “We are 100% committed to our customers and community.”

Each Monday, Cassie places an order for items that are listed in the sale flyer that goes into mailboxes. She checks out what products she needs to reorder and tries to look ahead to special events going on in town so the store will be able to have items available. Her actions are supported by a dedicated board of directors and a great staff. Each week a group of volunteers shows up on Thursdays to process the weekly order of products and put items on the shelves. This is why it's a real community venture!

While those walking in the front door may not realize it, there have been a number of updates this year.

- In April, Day of Champions students from Northern helped paint the front area, brushing on light yellow paint over the dark wall covering. Photos showing scenes from the early days are Frederick were framed by Tim Fugman and highlight the coffee area as conversation starters.
- The store is fortunate to have local gardeners bring in fresh produce to share.
- An anonymous donor has purchased a number of items, including school supplies, which are available at the store. Notebooks, glue sticks, pencils and pens are on a special shelf for those looking to stock up for school.
- One of the biggest items people may notice is that the store no longer has coolers sporting Coke and Pepsi logos. Those coolers once stood at the end caps of the aisles. Now the beverages



plus many more are in the aisle on the east side of the store.

- Memorial money from the Edwin Bretsch family provided funds to purchase a new cooler where those wishing a sandwich or snack can grab a quick lunch. Support like this goes a long way to keep the operation running.
- “We have been fortunate to work with Kevin at Ken’s SuperFair Foods in Aberdeen,” said Connie Groop, who is on the store board. “When their store put in new counters, they let us purchase one of the old ones to replace the one we had. Through the efforts of Cassie and her family plus Troy Millard, the modern checkout counter is a great addition.”
- A big thank you to Dale Geffre for tarring portions of the back roof where leaks were identified.
- The signage on the outside of the Community Store is faded and needs to be replaced. Cassie and the board are working with Wade & Kim Jensen of Imaginit who have generously donated a new sign to the store. They are working on a design. Watch for the new look!



### Store asks customers to use reusable bags rather than plastic

“At the store, we are looking at greatly reducing plastic bag usage. Insulated reusable shopping bags are available for purchase at the store,” Connie said. “One blog posts said that every year, one trillion single-use plastic bags are used, equating to about 2 million a minute. The average plastic bag is used for just 12 minutes, yet plastic bags take up to 1000 years to disintegrate. When we travel to bigger cities, customers are charged for using plastic bags and encouraged to use cloth or insulated bags. We may need to do that in the future.”



“Please let the staff know if they can help with shopping needs,” Cassie said. “If you are running short of time to shop, give us a call and we can put a grocery order together for you to pick up. If you stop by and we don’t have what you are looking for, let us know so we can order what you’d like. Call us at 605-329-2375.”

Connie reminds people, “Every dollar you spend at the Community Store helps us keep the doors open so you can grab those items you need without driving for miles. Thank you for your business!”

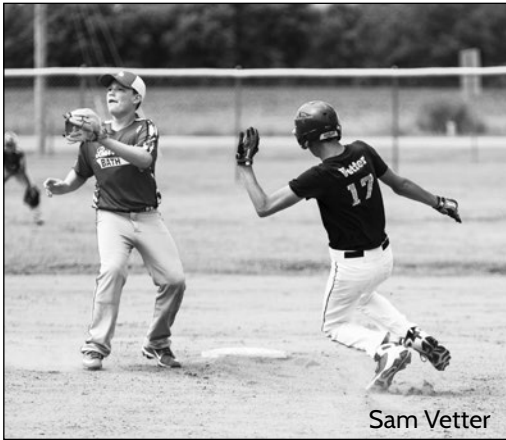

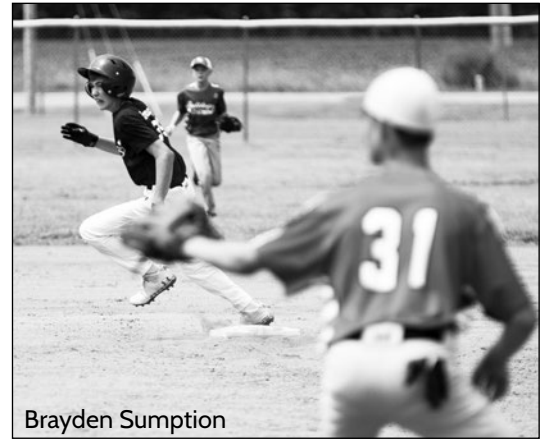
